**ORDER:**

In the reference third read above, the District Collector, Srikakulam has reported that the Hon'ble Chief Minister has reviewed the TITLI cyclone relief works with the District Administration and Senior Officers on 12-10-2018, 13-10-2018 and 14-10-2018 and made certain announcements for enhanced relief and financial assistance to TITLI cyclone affected persons. Accordingly the following scale of assistance applicable **only to TITLI Cyclone** affected persons is hereby ordered:

- 1. Gratuitous relief :** Rs.5.00 lakh for each death case.
- 2. Essential Commodities :** 25 Kgs Rice, 1 kg Dall, 1 ltr Palmolein Oil, 1 Kg Potato, 1Kg Onion, ½ kg Sugar per family. In case of Fishermen, it will be 50 Kg rice apart from other commodities. [This assistance is also applicable for the Vamsadhara flood affected persons].
- 3. Agriculture:** Paddy Crop damage: Rs.20,000/- per Ha. Other Agriculture Crops as per the SDRF Norms.
- 4. Horticulture** Crop damages:
  - i. Banana : Rs.30,000 per Ha.
  - ii. Coconut : Rs.1200/- per tree .
  - iii. Cashew : Rs.25,000/- Ha.
  - iv. Replantation of Coconut and Cashew-
    - (a) Small and Marginal Farmers - Rs.40,000/- per ha for re-plantation in 3 years time under MGNREGS.
    - (b) In case of big farmers, for both cashew and coconut, subsidy available under Government of India schemes and remaining will be borne by the State Government for total assistance of Rs. 40,000/- per ha in 3 years.
  - v. Removal of all fallen Coconut and Cashew trees from the farmer's field will be taken up by the SDRF/fire services department at free of cost.
- 5. FISHERIES :**
  - i) Fully damaged/lost FRP motorised boats: Rs.1.00 lakh compensation.
  - ii) Fully damaged/lost mechanised boats: Rs. 6.00 lakh.
  - iii) Loss of fishing nets : Rs 10,000/-
  - iv) Revival of Fishing activities by fishermen- 50% subsidy on purchase of Nets and Boats amounting up to total value of Rs. 3.00 lakh.
  - v) Input assistance for Aquaculture-Rs.30,000/- per Ha for loss of aquaculture.

**6. ANIMAL HUSBANDRY :**

- (i) For death and permanent disability of milch Buffalo and cows Rs.30,000/- (permanent disability to be certified by veterinary doctor ).
- (ii) For death of Goats and Sheep Rs.3000/- per animal.
- (iii) For damage of cattle shed Rs.10,000/-
- (iv) Construction of new cattle shed under MGNREGS for SF/MF (Gokulam)- Rs.1.00 lakh for 2 animals, Rs 1.5 Lakh for 3 animals and Rs 2.0 lakh for 4 animals..

**7. HOUSING :**

- (i) Rs.10,000/- for damaged houses.
- (ii) Assistance for construction of new housed in place of fully damaged houses- Rs.1.50 lakh for general, Rs. 2.0 lakh for SC and Rs. 2.25 lakh for ST categories.
- (iii) A.C roofing sheets- Free of cost- maximum of 10 sheets per house.

**8. Petty shops:** For fully damaged petty shops- Rs 10,000/-.

Items not mentioned in this G.O. will be covered under G.Os in vogue.

2. All the Heads of the Departments and the District Collector, Srikakulam and Vizianagaram are requested to send necessary proposals to the Government for release of budget.
